Shelter Services: The SPCA of Westchester contracts with several municipalities to accept stray cats and dogs for return to their owners or to arrange for them to be adopted. A no-kill facility, the SPCA is committed to caring for all adoptable animals until a new home can be found.

Humane Law Enforcement Division: The SPCA is the only animal welfare organization authorized by New York State to enforce its laws as they relate to animals cruelty in Westchester County. Investigations encompass cruelty complaints involving dogs, cats, horses, exotics and farm animals.

Simpson Spay/ Neuter Clinic: Through this facility the SPCA offers the public low-cost, spay/neuter surgeries, examinations, vaccinations and testing for diseases in an effort to help people keep their pets healthy. Since establishing the clinic in 1983, we have spayed or neutered approximately 63,000 dogs and cats.
