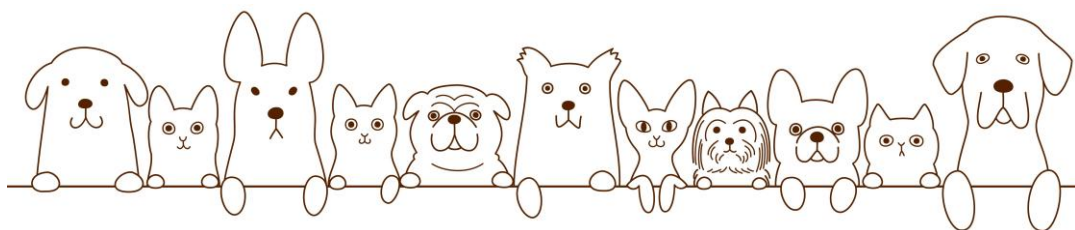

- The event takes place in the field next to parking lot #1
- Set-up begins as early as 7:30 a.m.
- You must provide your own table(s), chair(s), tent and signage.
- Each space is 10 feet wide by 10 feet deep. Your space will be marked the day of the event.
- Your vehicles **MUST** be off the field and in a parking lot by 9:30 a.m.-you may not park in the areas surrounding or behind Woof and Meowtown Village, or on the service road leading up to the field.
- There is no electricity on site.
- If you haven't provided the SPCA with your certificate of insurance at least two weeks prior to the event, you will not be permitted in and will not receive a refund.
- This event is rain or shine. Please note, we are unable to give refunds.
- The SPCA is not responsible for any theft or damage to your exhibit.
