A no-kill animal rescue center, the SPCA is committed to caring for all adoptable animals until a new home can be found.

Humane Law Enforcement Unit: The SPCA is the only animal welfare organization authorized by New York State to enforce its laws as they relate to animal cruelty in Westchester County. Investigations encompass cruelty complaints involving dogs, cats, horses, exotics and farm animals.

Cody's Clinic: The SPCA offers to the public affordable spay and neuter, wellness examinations, vaccinations and disease testing in an effort to help companion animals stay healthy. Since establishing the clinic in 1983, we have spayed and neutered more than 80,000 dogs and cats.
