Animal Rescue Center: Founded in 1883, SPCA of Westchester is one of the oldest humane societies in the United States operating independently and receiving no funding from any national animal welfare organization. Recognized as a no-kill shelter, the SPCA's Rescue Center provides a vital safety net for homeless animals and contracts with seven municipalities to accept stray cats and dogs, reunite lost pets with their families, and find new homes for those who are not reclaimed. In 2025, 1,785 dogs, cats, puppies, kittens, and small animals were adopted into loving new homes.

Cody's Clinic: As a low-cost veterinary clinic in Westchester County, Cody's Clinic provides affordable spay/neuter surgeries, wellness exams, vaccinations, microchipping, and disease testing for pets whose families might otherwise be unable to access care. In 2025, Cody's Clinic provided Trap-Neuter-Vaccinate-Return (TNVR) services to 484 community cats, delivered wellness care to 1,989 companion animals, performed 532 spay/neuter surgeries for publicly owned pets, and treated and supported 1,928 rescue animals in the SPCA's care. Cody's Clinic helps keep pets healthy, reduces shelter surrenders, and strengthens the human-animal bond.

Mission: SPCA of Westchester's mission is to lead in providing life changing care for animals through rescue and rehabilitation, justice, community education, and successful and lasting adoptions.

Vision: The promise of a future where our community's companion animals are safe, loved, and thriving.

The SPCA of Westchester is deeply grateful to the hundreds of volunteers who donate their time to support our Rescue Center and Cody's Clinic. Volunteers walk and train dogs, socialize and care for cats, provide enrichment and exercise, assist visitors through the adoption process, and support our administrative and veterinary teams. Their dedication helps create a safe and compassionate environment for every animal in our care.

**Form 990, Part III, Line 4b - Second Accomplishment**

Humane Law Enforcement Unit: The SPCA's Humane Law Enforcement (HLE) Unit is the only agency authorized by New York State to enforce animal cruelty laws in Westchester County. HLE officers investigate reports of animal abuse and neglect, rescue animals from dangerous and inhumane conditions, and work alongside local law enforcement and prosecutors to hold offenders accountable. Investigations involve a wide range of species, including dogs, cats, horses, farm animals, and exotic animals. In 2025, the HLE Unit received 1,154 calls to its cruelty hotline, opened 804 investigations, rescued 127 animal victims from abusive situations, and made four arrests related to animal cruelty offenses. Through its enforcement, rescue, and advocacy efforts, the unit serves as a critical lifeline for animals in need and a powerful voice against cruelty throughout Westchester County.

**Form 990, Part III, Line 4d - All Other Accomplishments**

Humane Education: Education is one of the most powerful tools for preventing animal cruelty and inspiring the next generation of compassionate animal advocates. Through engaging classroom presentations, interactive workshops, and on-site experiences at the Rescue Center, the SPCA's staff and volunteers teach children about kindness, empathy, responsible pet care, and animal welfare. Programs are tailored to the age, interests, and goals of each group, including schools, youth organizations, scout troops, and community groups. In 2025, the SPCA's humane education programs reached 1,540 children throughout the community.
